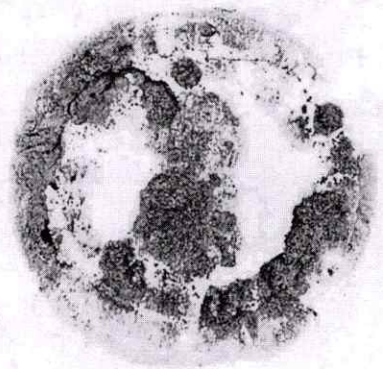

WHEREAS the SETTLER is inspired with the object of *Public Charity and Social Welfare of public* at large has decided and desired to create trust for objects as hereinafter mentioned and for fulfillment of the above desires, the SETTLER desires to settle a sum of Rs. 10001/- (**Rupees Ten Thousand and One only**) upon Trust for purpose of Public Charitable Objects and purposes hereafter expressed.

AND WHEREAS the Trustees have agreed to become Trustees and to hold and apply the said sum of Rs. 10001/- (**Rupees Ten Thousand and one**) only and all gifts, contributions, subscriptions, donations and all other sums of properties that may from time to time form part of the "TRUST FUND" hereby created.

NOW THIS DEED OF TRUST witnesseth as under: -

1. In order to effectuate the said desires as referred above the settler both irrevocably transfer and make over unto the trustees the sum of Rs 10001/- (**Rupees Ten Thousand and one only**) and to hold the same, all gifts, contributions, subscription, donations, and other money or properties as and when the same shall be paid, to be received or vested in them and the money and investments and properties from time to time representing the same and all additions & accretions thereto and all accumulated Income thereof ( hereinafter referred to as the "TRUST FUND") upon trust for the objects and purposes hereinafter contained concerning the same.
2. The name of the Trust shall be "JAGANNATH GUPTA FAMILY TRUST" and the office of the trust shall be situated at 26, Ganesh Chandra Avenue, Kolkata-700013. The trustees shall open branch offices of the Trust at any other place or places as decided by the Board of Trustees from time to time.

3. That the objects for which this TRUST is established are:

- (a) To establish, develop, maintain and grant aid in cash or in kind to Hospitals, Medical Schools, Medical Colleges, Engineering Colleges, Technical Educational, College, Nursing Institutions, Dispensaries, Maternity Homes, Child Welfare Centre and/or such other similar Charitable Institutions in India for the benefit and use of the general public.







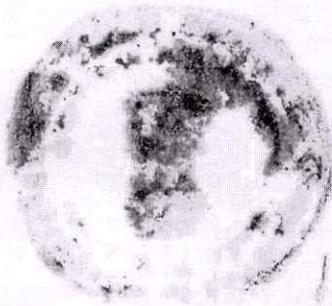

(b) To establish, run, support and grant aid or other financial assistance to Schools, Colleges, Social Service Centre, Industrial Training Centre, Libraries, Reading Rooms, Universities, Laboratories, Research and Other Institutions of the like nature in India, for use of the students and the staff and also for the development and advancement of education and diffusion of knowledge amongst the public in general.

(c) To establish, maintain and run studentships, scholarships and render other kind of aid to students including supply of books, stipends, medals and other incentives to study, without any distinction as to caste, colour, race, creed or sex.

(d) To promote, establish, support, maintain or grant aid to institutions for the promotion of science, literature, music, drama and fine arts, for the preservation of historical monuments and for the research and other institutions, in India, having similar objects for the benefit of the public in general.

(e) To establish, maintain or grant aid for the establishment and/or maintenance of parks, gardens, gymnasiums, sports clubs, dharamshalas and rest houses, for use by public in general.

(f) To establish, maintain or grant aid to homes for the old aged, orphanages or other establishments for the relief and help to the poor, needy and destitute people, orphans, widows and old aged persons.

(g) To establish and develop institutions for the physically handicapped and disabled or mentally retarded persons and to provide them education, food, clothing or other help.

(h) To grant relief and assistance to the needy victims during natural calamities such as famine, earth quake, flood, fire, pestilence, etc. and to give donations and other assistance to institutions, establishments or persons engaged in such relief work.

(i) To construct repair and manage the marghats, cemeteries and burial grounds.

(j) To grant aid or render assistance to other public charitable trusts or institutions.

(k) To foster inquiry and awareness concerning the human, ethical and Philosophical dimensions of science and technology,

(l) To promote intercultural studies in philosophy, through scholarly dialogue between the Philosophical traditions of India and other traditions, on questions of contemporary knowledge and practice,

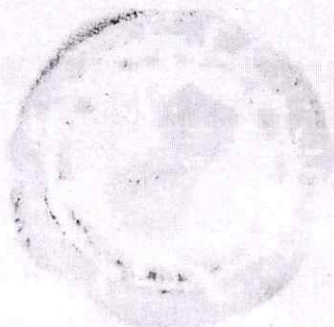
(m) To Initiate and undertake programmes of research and education designed in consultation with distinguished experts in the relevant fields,

#### 4. AREA OF OPERATION:-

The activities of the trust shall extend to the whole of India and the geographical area of operation for the trust will include covering the whole of India.

#### 5. MANAGEMENT

5.1 The Management of the affairs of the Trust shall always vest in the Board of Trustees and they shall have all the powers incidental to and necessary for carrying out the objects from which this trust is created.

5.2 All or any of the powers vested in and exercise by the Trustees hereunder shall be capable of being performed by or a majority of the Trustees thereof, for the time being and any action or decision of the majority shall be valid and effective as would have been done by all the Trustees.

The Board of Trustees shall ordinarily consist of minimum 3 (three) and not more than 21 members. The trustees may elect among themselves one person to act as Chairman. The Trust Board can create more post of office bearer if deemed necessary.

5.3 The Settler of the Trust shall be a life member of the Board of the Trustees.

5.4 The First Trustees shall hold office for a period of Five Years from the date of appointment and they are eligible for re appointment.

5.5 New Trustees may be nominated in the Trust by the Board at any time who shall also hold office for 5 Years from the date of appointment.

5.6 The Trustees as mentioned in this deed are the FIRST Trustees of the Board.

5.7 The following persons shall form the *FIRST Board of the Trust:-*

1. JAGANNATH GUPTA son of Late Shyamlal Gupta by religion Hindu residing at 502,M.G.Road Po.&Ps. Budge-Budge District South 24,Parganas Kolkata-700137.

2. SMT. URMILA DEVI GUPTA wife of Sri Jagannath Gupta, by religion Hindu residing at 502,M.G.Road Po.&Ps. Budge-Budge District South 24,Parganas Kolkata-700137.

3. KRISHNA KUMAR GUPTA son of Sri Jagannath Gupta, by religion Hindu residing at 502,M.G.Road Po.&Ps. Budge-Budge District South 24,Parganas Kolkata-700137.

4. SMT. ARTI SHAW wife of Sri Ajay Shaw ,and daughter of Sri Jagannath Gupta, by religion Hindu residing at 502,M.G.Road Po.&Ps. Budge-Budge District South 24,Parganas Kolkata-700137.

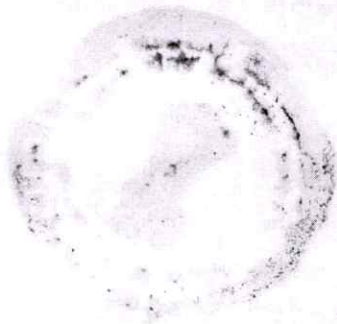
Vacancy if any arising due to death, expiry or resignation or any other reason by any trustee shall be filled up by the Board of Trustees.

5.8 The First trustees named above and other trustees who may be inducted hereinafter into trust can voluntarily demit the office of the Trusteeship by conveying the same in writing to the SETTLER and such a communication shall be deemed to have created a vacancy in the Board.

- (c) if he becomes a lunatic or a person of unsound mind
- (d) if he voluntarily resigns from his office

## 6. MEETING OF THE TRUSTEES

- 6.1 The Board of Trustees shall hold meeting at an interval of every three months and in case of emergency, meeting can be called at any time by the General Secretary for considering the agenda.
- 6.2 The Quorum of the meeting shall be one third of the members; subject to minimum of two.
- 6.3 The Chairman of the Board shall always preside over the meeting and in his absence the Vice Chairman shall preside and in the absence of both of them the meeting shall be presided over by any member of the Board who shall be invited by the members present at the meeting.
- 6.4 The decision of the majority of the Board members shall be final and in case of voting the chairman of the meeting shall have a casting vote.
- 6.5 The resolution as adopted in the meeting shall be recorded and should be ratified in the subsequent meeting.

## 7. POWER AND DUTIES OF THE BOARD OF TRUSTEES:

The Trustees shall have the following powers:

- 7.1 To apply the whole or part of the Trust fund for one or more objects of the Trust.
- 7.2 To accept gifts or contributions in cash or kind or in properties movable or immovable for the objects and purposes of the trust to any institution, society or trust established in India.
- 7.3 To make gifts of any property movable or immovable belonging to the Trust to any institution, society or trust established in India.
- 7.4 To invest the Trust Fund and income thereof in the purchase of immovable properties on in Bonds, Government Securities and other permitted investments.
- 7.5 To sell, deal with dispose of, or alienate, mortgage, let out or otherwise transfer any movable or immovable property that may be comprised in the Trust fund and to invest the sale proceeds thereof in any manner as the trustees may think fit.
- 7.6 To pay all charges, impositions and other outgoing payable in respect of the Trust Fund or any property comprised in the Trust and to pay all costs on and incidental to the administration or management thereof.
- 7.7 To compromise, compound and refer to arbitration all matter suits proceedings and disputes touching the fund.
- 7.8 To appoint attorneys or agents and to delegate to such attorneys or agents all or any of the power vested in them.
- 7.9 The Trustees shall open and maintain in the name of the Trust, Banking Account

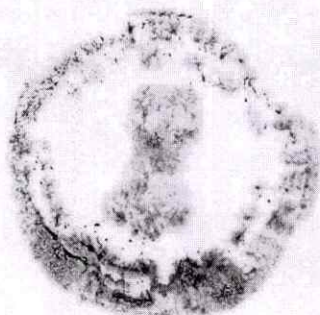

any two other persons to operate such Banking account by passing suitable Board Resolutions to the effects.

7.10 To draw, make accept negotiate, endorse, discount, execute, and issue promissory notes, bill exchange, debentures and other negotiable and transferable instruments securities.

7.11 The Trustees shall cause proper books of accounts to be regularly maintained of all monies received and expenses incurred.

7.12 The Trustees shall not be entitled to receive any remuneration as trustees but may reimburse of all expenses actually incurred by them in connection with the Trust or other relating thereto. However, if any Trustee works in his professional capacity he/she may be allowed such remuneration as decided by the Board by passing a resolution to this effect.

7.13 A Trustee will not be liable for any loss or damages to the Trust Fund unless caused by his/her own willful conduct or default.

7.14 The Trust shall follow the English Financial Year as the Financial Year of the Trust and Accounts of the Trust shall, be maintained accordingly.

7.15 The Board of Trustees may appoint advisory bodies, committee, Sub- committees and entrust with them the power to exercise or administer the activities undertaken by the Board while carrying out the objects of the Trust and incur necessary expenses thereof for proper and efficient administration and the activities of the Trust.

## 8. INVESTMENT OF TRUST FUNDS

The Trust funds shall be invested only in the modes specified under the provisions of section 13(1) (d) read with section 11(5) of the Income Tax Act, 1961. As amended from time to time.

## 9. DISSOLUTION/DETERMINATION OF THE TRUST

In the event of the determination of the trust or in case the Trust could not continue or pursue its objects, the Trustees in their duly constituted Board Meeting and the Trust by amalgamating or merging with another Trust\Institution having similar objects and donations to which are exempt under section 80G of the Income Tax Act, 1961. . On such winding up and merger the funds, properties and other assets and liabilities shall be handed over and vested with the other Trust\Institution and that in no event shall the assets so remaining be distributed among the trustees.

## 10. ACCOUNTS OF THE TRUST

The Accounts of the Trust shall end on the 31st March of every year and shall be subject to audit.
